**MEETING CALLED TO ORDER:** Dr. Patricia Treadwell called the meeting of the Indiana Medicaid DUR Board to order and welcomed everyone.

**APPROVAL OF MINUTES:** Dr. Eskew moved approval of the minutes from the November meeting. His motion seconded and carried with a unanimous vote.

**OPENING COMMENTS:** Marc Shirley reminded Board members to please e-mail the Board chair, with a cc: to himself and Board secretary Ms. Karen Clifton, as soon as possible in the event of an inability to attend any given Board meeting.

**ELECTION OF OFFICERS:** Brian Musial was nominated as chair of the DUR Board. The motion was seconded and carried with a unanimous vote. Dr. John Wernert was nominated as vice-chair of the DUR Board. The motion was seconded and carried with a unanimous vote.

**ACS UPDATE:** Dr. Randall Renshaw, PharmD, BCPS, ACS Executive Account Manager presented the prior authorization statistics for the month of November 2008. There were a total of 3,709 PAs entered for the month of November.

**EFFECT OF IMPLEMENTING A PA REQUIREMENT FOR DRUG-DRUG SEVERITY ONE**

**INTERACTIONS:** Dr. Renshaw stated that ACS would like additional time to finesse the data on this topic and respectfully requested this agenda item be moved to the January DUR board meeting. Dr. Treadwell agreed to move this agenda item to the January board meeting. Dr. Lindstrom asked if the correction requested at the November meeting was made to the table on page 2 of the September 2008 DUR Board newsletter. Dr. Renshaw stated that no change was necessary and pointed out that Dr. Lindstrom had mistakenly referred to an uncorrected draft copy of the *State of Indiana Medicaid DUR Annual Report, FFY 2007*. Dr. Renshaw pointed out that the numbers in Table II found on page 157 of the Annual Report do match the numbers found in the table found on page 2 of the newsletter.

**MANAGED CARE ORGANIZATION UPDATE:**

- Proposed PDL Changes—MDwise: Chris Johnson of MDwise summarized the changes that were sent to the Board.

It was moved, seconded and carried with a unanimous vote with one abstention. Mike Sharp pointed out that it was the intention of OMPP to “carve-out” the pharmacy benefits from the Managed Care Organizations as of July 2009 thus bringing these patients back into the Medicaid fee-for-service population.

- Proposed PDL Changes—Anthem: Ms. Jeannine Murray of Anthem summarized the changes that were sent to the Board.

Changes were moved, seconded and carried with a unanimous vote.

- Proposed PDL Changes—MHS: Ms. Butler of MHS summarized the changes that were sent to the Board.

Changes were moved, seconded and carried with a unanimous vote.
